# **BUSINESS STARTUP CHECKLIST**

Use this checklist to begin working with the Illinois Small Business Development and International Trade Center at College of Lake County and ensure your efforts to start a business are successful. Registration is the first step to working with the SBDC-ITC.

### SBDC Registration and Startup Advising

- 1. *Required:* Register as a client with the Small Business Development & International Trade Center (SBDC-ITC) at College of Lake County.
- 2. *Strongly Recommended:* View the 1-hour, online <u>Starting Your Business in Illinois presentation</u> to learn the basic elements of a successful business startup.
- 3. Schedule a one-on-one advising session with an SBDC advisor that specializes in startup advising.

#### **Basic Startup Resources**

- 1. **Read the Starting Your Business in Illinois Handbook** in *English* or *Spanish*, which provides a wide variety of information and state and federal resources for small business.
- 2. Join the no-cost BizHub community, which connects businesses to critical success resources.
- 3. **Create a simple business plan using <u>Business Model Canvas</u>**. Access the Business Model Canvas tool on BizHub.
- 4. **Create a comprehensive business plan** using the <u>Step-by-Step Business Plan Workbook</u> or LivePlan business planning software (see your <u>SBDC advisor</u> for LivePlan details).

### Business Registration, License, and Regulations

- 1. **Determine the best legal entity to form for your business.** Explore the Starting Your Business in Illinois Handbook and BizHub for assistance forming a legal entity. **Apply for a legal entity** through the Illinois Secretary of State.
- 2. **Get an** Employer Identification Number (EIN) to register your business and pay taxes or an Individual Taxpayer Identification Number (ITIN) if you do not have a social security number.
- 3. <u>Complete an Illinois Business Registration form</u> to register as an employer with the Illinois Department of Revenue.
- 4. **Consider the need for commercial liability insurance** and purchase coverage if applicable. Explore BizHub for commercial insurance providers.
- 5. Apply for applicable federal and state licenses and permits.
- 6. **Contact your local village hall for information** about licenses, permits, parking, restrictions, signage requirements and more. Explore BizHub for information about your local village hall.
- 7. Work with the Lake County Health Department to receive training and permits for food related businesses.

## Business Registration, License, and Regulations continued...

8. <u>Complete an Assumed Business Name Form</u> from the Lake County Clerk's office if you plan to be a sole proprietor.

## **Business Finance and Accounting**

- 1. Calculate startup costs using Small Business Administration (SBA) resources.
- 2. Explore BizHub for business funding sources.
- 3. Establish a commercial banking account. Explore BizHub for commercial banking options.
- 4. **Provide for accounting and tax preparation needs.** Explore BizHub for accounting and tax providers.
- 5. Obtain a Sales and Use Tax Permit if applicable.

### **Business Training**

- 1. <u>Register for TAD (Training/Assessment/Development)</u> platform, which provides a wide variety of training and skill building programs. This online tool is currently provided at no-cost.
- 2. <u>Attend no-cost and low-cost training programs to strengthen your skills</u> in a wide variety of areas. Important startup topics include Startup & Planning, Marketing & Sales and Accounting & Finance.
